6. Bids must be submitted to the office of the sunawarshi municipality by hand or courier on before 12:00 noon on 2083/06/30 (16th of Oct. 2026). Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 noon on 2083/06/30 (16th of Oct. 2026) at the office of **Sunawarshi Municipality, Dainiya Morang**. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security, amounting to a minimum of **Amount mention in 4th column** which shall be valid for 30 days beyond the validity period of the bid (i.e. 2083/10/28 (11th of Feb. 2027))
8. If the last date of purchasing, submission and opening falls on government holiday then next working day shall be considered the last date. In such case the Bid validity and Bid security shall Remain the same as specified for the original last date of Bid submission.
